1. Introduction

Papers submitted to NCC-2012 must be printed in the style shown in this sample. Note that the title and author names are at the start of the 1st page and not as a cover page. The soft copy must be in pdf format. The title, author names, and addresses should be centered.

The paper, including text, tables, references and illustrations, should not exceed 5 (five) A4 pages. The pages should have a page number printed at the bottom of the page in the centre. The paper must be in two-column format. Figures should also be in one of the columns. However, if necessary, figures may span both columns.

2. Fonts and margins

The fonts and spacing to be used are described herein

2.1 Fonts :

Please use the Times New Roman font. Do not indent the paragraphs. The font sizes are as follows :

1. Title: Bold, 20pt.
2. Author names: Italics, 12pt.
3. Author addresses: Normal, 10pt.
4. Section headings: Bold, 16pt.
5. Subsection headings: Bold, 12pt.
6. Body of the paper: Normal, 10pt.
7. Reference : Normal 9pt.
8. References Caption : No section number, Italics, 12pt.
9. Gap between authors' addresses & text body : Two lines
10. Spacing between sections : One line
11. Inter paragraph spacing : One line
12. Interline spacing : single space.
13. Gap between body text / figures and page numbers : 0.5 inches.

2.2 Margins :

- a. Top margin : 0.75 inches
- b. Bottom margin : 0.75 inches
- c. Left and right margins : 0.75 inches each
- d. Column separation : 0.25 inches

3. Publications

All accepted papers will be published in the Proceedings provided :

1. They conform to the format specified in the sample.
2. On intimation of acceptance, at least one of the authors for each paper registers by the date specified, along with the appropriate registration fees.

However accepted papers even those which are not included in the proceedings can be presented at the conference provided an author registers at the conference. These will be listed in the Advance Programme if due intimation with registration fee is given.
